- 1. The deadline for submitting your nomination to the Caldwell Board of Realtors is January 12, 2024. All applicants and completed work must be received by 5:00 p.m. MST on this date. Applications received after the deadline will not be accepted.
- 2. Information must be submitted for activities during the past 5 years only.
- 3. Do not "short-change "your candidate with insufficient application information. You must solicit their help for information either before or after your local selection is made.
- 4. Please submit a photograph with your nomination form as we profile local board/association ROTY's throughout the year.

5. If your candidate was previously CBOR ROTY they will not be eligible to be an applicant again no matter the length of years since previously winning the CBOR ROTY.
